3 Petition for Correction of Gender/Sex Birth Date Birth Month in the Birth Certificate (Pursuant to RA No. 10172)

WHO MAY FILE THE PETITION?

a. Correction of Gender/Sex

The document owner shall file the petition personally. In case of minority, he or she shall be assisted by parent or guardian and shall appear before the Civil Registrar.

b. Correction of Birth Date and/or Birth Month

1. Document owner
2. Document owner's spouse, children, parents, brothers, sisters, grandparents or guardian, or any other person duly authorized by law or by the document owner in a Special Power of Attorney

WHERE TO FILE THE PETITION?

a. Correction of Gender/Sex

The document owner shall personally file the petition at the Office of the Civil Registrar where the birth certificate is registered and kept.

In case the document owner is deceased already, the petition shall be filed in court.

b. Correction of Birth Date and/or Birth Month

As a general rule, the petition shall be filed with the Office of the Civil Registrar where the birth certificate is registered and kept.

But when the document owner or the petitioner had already migrated to another place within the Philippines, a migrant petition may be filed with the Office of the Civil Registrar of the place where he/she is presently residing or domiciled. The petition will be transmitted to the Office of the Civil Registrar where the birth certificate is registered and kept.

WHAT ARE THE REQUIREMENTS?

1. **Birth Certificate** sought to be corrected (PSA & Local Copies)
2. **Petition** duly subscribed by any person authorized to administer oath (RA 9048 Form No. 4.1)
3. **Baptismal Certificate.** If not available, please ask a **negative certification** from the church and execute an **Affidavit of Explanation** stating the reason of unavailability.
4. **Earliest School Records (Form 137-E).** If not available, please ask a **negative certification** from the school and execute an **Affidavit of Explanation** stating the reason of unavailability.
5. **Medical Records.** If not available, execute an **Affidavit of Explanation** stating the reason of unavailability.
6. **Medical Certificate** issued by an accredited government physician expressly stating that the document owner has not undergone sex change or sex transplant. (Davao Regional Medical Center or City Health Office) **(For correction of sex/gender only)**
7. **Police Clearance**
8. **NBI Clearance**
9. **Certificate of Employment, if employed, or Affidavit of No Employment, if unemployed**

10. **Newspaper Publication** (A Notice of Publication will be issued only when the petition is received. It will be published in a local or national newspaper, whichever is applicable.)

11. **Express Pouch, Phil Post Office or Prepaid Pouch,** private courier (Optional)

12. **Postal Money Order** (Payment for annotated birth certificate in Security Paper)

a. Amount: P140.00

b. Payee: Philippine Statistics Authority, Quezon City

c. Payor: Flordeliza J. Zulueta, City Civil Registrar,
Tagum City

13. **PSA's Application Form-Birth Certificate**

(Note: For migrant petition, please submit requirements 1-11 only.)

HOW MUCH ARE THE FEES AND CHARGES?

(Please refer Fees at the back.)

IMPORTANT TIPS/INFORMATION:

1. It is highly recommended that the birth certificate to be petitioned will be initially assessed by the Front Desk Officer (Tables 5, 6 or 7) to properly guide the document owner or petitioner on the appropriate remedy or action to be taken.
2. When the petition is received by our office, it will be posted for ten (10) days and will be published in a newspaper of general circulation for two (2) consecutive weeks before the City Civil Registrar will grant or deny the petition. Then it will be endorsed to the Office of the Civil Registrar General, Philippine Statistics Authority, Quezon City for affirmation. When affirmed, our office will issue a Certificate of Finality and will prepare the annotation in Birth Certificate. If impugned, a Motion for Reconsideration will be filed.
3. For migrant petition, it will be posted also for ten (10) days and will be published in a newspaper of national circulation for two (2) consecutive weeks before the petition will be transmitted to the Office of the Civil Registrar where birth certificate is kept and registered.
4. To avoid complications in the assessment and filing of petition, **FIXERS ARE NOT ALLOWED.**
5. Our office observes **"NO-NOON BREAK"** Policy.
